



Juvenile Justice Reform Act of



- removing young people from adult facilities, with limited exceptions;
- keeping young people who are incarcerated separate from incarcerated adults; and
- requiring states to identify and work to reduce racial and ethnic disparities in the juvenile justice system.

• It begins prior to birth, and continues throughout a child's development and across all the stages, into adulthood.






The First Five Years



One in three children entered foster care in 2017 because of parental drug abuse

- Of the states with the highest rates of opioid overdose deaths in 2016 (West Virginia, New Hampshire, Ohio, the District of Columbia, Maryland, and Massachusetts).
- West Virginia had both the highest opioid overdose death rates and foster care rates.

 Kids in the highest-homicide areas are more likely to come from poverty and perform lower on state tests.







In the California State University system, which admitted about 72 percent of first-time freshman applicants in 2014, more than 40 percent of incoming freshman were deemed not ready for collegelevel work in at least one subject.


Rick-Youth
